

customer data at-rest does not leave Switzerland

Region pairing enables geo-replication for data backup,

in-country disaster recovery as a plus

• Based on the **same trust principles** as our global offerings





- Azure IaaS and some PaaS (Azure SQL DB, Cosmos DB) launched in August 2019
- Further Azure services are deployed in Switzerland step-by-step
- Microsoft 365 launched in December 2019
- Power BI launched in June 2020
- First Dynamics 365 workloads and Power Apps / Power Automate launched December 2020
- Further D365 and Azure services continue to be deployed
